

### **USA PATRIOT ACT COMPLIANCE CERTIFICATE**

#### I certify that:

- 1. I am an officer, director or trustee of the Organization named below, and I am authorized to execute this Certificate on behalf of the Organization named below.

If the Organization receives US\$10,000 or more in Howmet Aerospace and/or Howmet Aerospace Foundation grants in any single calendar year, it will permit Howmet Aerospace and/or Howmet Aerospace Foundation to review and audit its financial records and statements as they relate to the use of these funds.
- 12. The Organization attests that no Howmet Aerospace and/or Howmet Aerospace Foundation employees will receive any benefit, service or money if it is awarded a Howmet Aerospace and/or Howmet Aerospace Foundation grant.
